**BMP** – Best Management Practices

**CASGEM** – California Statewide Groundwater Elevation Monitoring

**CBI**- Consensus Building Institute- organization that facilitates SGMA implementation

**Department**- Butte County Department of Water and Resource Conservation

**DMS**- Data Management System

**DWR** – California Department of Water Resources

**Flood-MAR**- An integrated and voluntary resource management strategy for using flood water for managed aquifer recharge (MAR)

**GDE**- Groundwater Dependent Ecosystem

**GPAC** – Groundwater Pumper Advisory Committee

**GSA** – Groundwater Sustainability Agency

**GSP** – Groundwater Sustainability Plan

**HCM**- Hydrogeologic Conceptual Model

**IM**- Interim Milestone – targets set in increments of 5 years over the implementation period of the GSP offering a path to sustainability

**IRWM** – Integrated Regional Water Management

**IRWMP** – Integrated Regional Water Management Plan

**JPA** – Joint Powers Authority

**MO**- Measurable Objective- Quantitative target that establishes a point above the Measurable Threshold that allows for a range of active management to prevent Undesirable Results

**MoOF**- Margin of Operation Flexibility- range of active management between the Minimum Threshold and the Measurable Objective

**MT**- Minimum Threshold- Quantitative threshold for each Sustainability Indicator used to define the point at which Undesirable Results may begin to occur

**NSV** – Northern Sacramento Valley

**PMAs**- Projects and Management Actions

**RMS**- Representative Monitoring Site

**SGMA** - Sustainable Groundwater Management Act ([link](#))

**SHAC**- Stakeholder Advisory Committee (advisory to Vina GSA Board)

**SI**- Sustainability Indicator

**SMC**- Sustainable Management Criteria
